

Parents information nursery & kindergarten No. 4-21

Dear Parents,

First of all, we want to inform you in this update that the state of Hesse will maintain the existing regulations for visiting daycare centers and schools until February 14, 2021. As already reported, the regulation for the daycare centers exists in the form that the use of the kindergarten place is aimed at the parents of the children for whom there is an "urgent need for care". At the same time there is no entry ban in the facilities.

This means: The daycare centers remain open and the parents decide on their own responsibility about the need for care for their child.

The last three weeks - thanks to your cooperation - have passed in the facilities without any noteworthy new infections. The hygiene concepts practiced were again designed in a more differentiated manner with regard to implementation and intensively discussed in the facilities under the leadership of the respective management. We are aware of what the parents manage who look after their child at home and who currently do not use daycare. It is positive that the number of new infections is generally falling, but the level is still too high. Scientific evidence also suggests that various mutations are significantly more infectious than the virus known to us. Therefore, more caution is required - also in our daycare centers and schools.

Today we would like to inform you about the **reimbursement procedure** for the months January 2021 and February 2021 in the daycare centers.

Since our facilities are located in different municipalities, whose regulations are structured differently, the reimbursement regulations are not uniformly, as the requirements of the municipalities must be observed. Furthermore, the financing contracts between the municipalities are different. This results in different reimbursement amounts. Let us first outline the regulation for **January 2021**:

Parents whose child is not in daycare in January receive the proportionate regular monthly fee back.	Parents who did not make use of any daycare for their child on the days in January will not be charged the monthly fee.	A fee reimbursement takes place within the framework in which the State of Hesse is willing to consider a reimbursement.
When daycare was used 10 days per month looking a reimbursement of 50% of the above amount will be made	The refund will be made as soon as on the part of the city the requirements are met.	There is still a need for clarification with the city. These parents will be informed separately.
If the care is used for more than 10 days, there will be no reimbursement.		

You will receive the material and meal costs back in accordance with the non-use in the month of January 2021 on the basis of the remuneration agreed in the care contract. We provide all parents with a form via the facility in which they document the days of care for their child. For January 2021 then a notification about the amount of the waiver. The money will be returned to your account. We ask you not to offset the following months.

The following reimbursement or suspension regulation is planned for February 2021:

With a care of up to 10 days A reimbursement of 50% of the above amount will be made		
If the care is used for more than 10 days, there will be no reimbursement.		

You will receive the material and meal costs back in accordance with the non-use in February 2021 on the basis of the remuneration agreed in the care contract.

We are also providing all parents with a form via the facility for February 2021, in which they document the days of care for their child. The return takes place at the end of February. The billing will then also take place retrospectively.

We hope that with this information we have explained the main features of the billing process. We do everything we can to keep our facilities open. This also includes further equipping the group rooms with air purification devices. Another delivery of sixty powerful devices arrived today (January 22nd). The assembly of these devices will take place in the near future.
